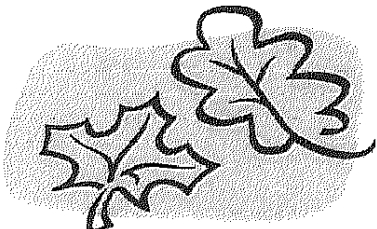

The First Annual Jackson Alive---The Family Festival is being brought to you by Butts County Chamber of Commerce & Greater Butts County Lions Club. It will be held from United Bank (Covington Street) to Butts County Administration Building and around the Courthouse square in downtown Jackson, Georgia on October 2, 2010 from 9am until 5pm. A number if activities are planned for the day which will bring many people into the county. You may download additional information from our website buttscochamber2@bellsouth.net.

Vendor spaces are located on areas along Second and Third Streets and the area surrounding the Courthouse. All vendor spaces are 12 feet x 12 feet. Game/ride spaces are larger and are located in areas according to the game/ride in the different Children's Play areas. All vendors who require electricity pay a \$25.00 fee per space and furnish their own water. YOU MUST FURNISH YOUR OWN TENTS, TALBES AND CHAIRS. All tie-downs must be self-contained. NO STAKES can be driven into the streets/sidewalks. The City of Jackson will impose a fine if stakes are driven into streets/sidewalks.

Being that there is limited space available all applications may not be accepted and vendor spots are filled on a first-come, first served basis. Check in time and set up is at 6 am. Your number and location will be assigned at check in and you will be provided with a location map. ALL VECHICLES MUST BE MOVED TO OFF-SITE PARKING BY 8:30 AM.
